

## **Shower Protect Plus Limited Five (5) Year Warranty for Professionally (Technician) Installed Service**

Nanovations USA warrants that shower glass treated with Shower Protect Plus will remain water resistant for a period of five (5) years from the date of application. Shower Protect Plus must be applied by a technician trained to perform the process to validate and maintain the warranty. This warranty covers the replacement of adequate product to re-coat the affected shower glass area at no cost.

This warranty does not cover the following:

1. Any glass, other than the technician applied treated shower glass.
2. Any service or labor costs related to the re-application of Shower Protect Plus.
3. Any treated shower glass that was cleaned with harsh chemicals.
4. Any treated shower glass past the five (5) year warranty.

To obtain the benefit of this warranty, purchaser must contact the Company that installed Shower Protect Plus and provide this warranty card, filled out by the technician during the original application, along with receipt of original service. A technician from the Company that installed Shower Protect Plus will be sent to determine if the glass has been maintained properly and that no harsh chemicals were used to strip or affect the coating. If the technician approves the warranty, they will re-coat the affected area that day or at a later date. Retreated glass will be covered under the original warranty time frame of five (5) years and will not be given a new warranty. If the technician determines that the basic maintenance recommendations have not been followed, then they and Nanovations USA shall be released from any obligation or liability under this limited warranty.

This warranty covers only the original purchaser of the glass treatment application. This warranty is not transferrable to subsequent owner or purchaser of treated shower glass.
